# CHAIR'S REPORT



It is my pleasure to present this year's Annual Report on behalf of the Auckland Airport Community Trust.

The Trust was established in 2003 for the mitigation of the adverse effects associated with aircraft operations within defined areas. This is achieved by ensuring there is positive social investment in the Community to offset any negative effects.

## COMMUNITY GRANTS

In 2015, the Trust announced grants to thirteen projects totalling \$311,823.23. The projects all aimed to improve literacy or life skills within our communities. Some of these projects were small and community-led, whilst others were larger and sit more strategically as local components of larger regional initiatives.

This year, the funding round was well subscribed, reflecting both the high level of need in the Area of Benefit and the increased competition for funding in the not-for-profit sector. The Trust received applications for funding in excess of \$1.2 million, meaning that the Trust had to be very selective in its decision-making. We are delighted to share some examples of the funding awarded in this annual report.

During the year, Auckland Airport announced a new offer of a Noise Mitigation Package to assist owners of homes most affected by aircraft noise with the opportunity to help reduce the impact inside their homes. The Trust will once again be offering Financial Assistance Grants to those that are eligible to cover the 25% cost of the installation that is not covered by Auckland Airport.

## FINANCIAL PERFORMANCE

The Trust received an annual payment from Auckland Airport Limited from which grants are made in the local community. Set at \$250,000 in 2003 and adjusted each year by the compounded value of the CPI, the amount received this financial year was \$328,415. With interest received, the Trust's total income was \$347,221.

The Balance sheet shows unpaid distributions of \$346,146. This reflects the timing of announcing the successful grants at the end of the financial year. A full list of these grants and those paid previously are detailed in this report.

The Trust ended the year with a balance of \$150,551 in Trustee Reserves.

## GOVERNANCE & APPRECIATION

I would like to take this opportunity to thank the Trust's outgoing Chair, Martin Fryer. Martin's contribution and dedication during his 9 year tenure, one of which was as Chair, has been greatly appreciated by all he has served. The Trust also wishes to acknowledge Dawn Engelbrecht's contribution as Chair, for two years and Trustee for a further year.

Over the year we have welcomed Jill Harrison as an Auckland Council representative on the Board and Kate Thompson as our incoming Auckland Airport appointee. Special mention also needs to be made of the strong support from our Trust administrators – Auckland Communities Foundation.

Last, but probably most important, thanks to our Appointers, our community stakeholders and those of you who support the people that live and work in the Area of Benefit. It has been a privilege to serve you.

## YOUTHLINE

### SUPPORTING OUR YOUTH - SUPPORTING OUR COMMUNITIES

Youthline, established over 40 years ago, has a vision of creating communities which relate to the needs of young people, respond to them, and support them to achieve their potential.

Youthline is sincerely grateful to the AACT for providing financial support to our South Auckland youth development services since 2012.

Youth development research shows that by utilising a wraparound approach of services the impact for young people is more significant and long lasting. Youthline's South Auckland Community Centre provides accessible free and low-cost services including our national crisis helpline, a clinical services team consisting of counsellors and youth workers providing individual mentoring, development and leadership programmes to schools and training of Youthline volunteers.

Last year Youthline received over 275,000 helpline requests, provided individual mentoring and counselling to over 40,000 youth, delivered youth development programmes and seminars to over 9,075 students and provided training to over 180 helpline volunteers. This would not have been achievable without the ongoing support of the AACT.

Specifically in the South Auckland region AACT funding went towards the youth worker team providing programmes to schools and one on one mentoring to at risk young people.

Youthline works across a continuum, from those young people who are most vulnerable to youth leaders who are and championing change.

Youthline's youth development programmes are delivered in high schools. We provide eight week programmes to help build confidence and self-esteem, improve decision making, address addiction issues as well as assist with the transition into employment.

Our youth workers also facilitate youth leadership programmes including "Youth Health Councils". Youth Health Council student volunteers identify the health and wellbeing needs of their

peers and coordinate relevant events, speakers and activities to inform and help their fellow students. With the support of the AACT Youthline provided youth development and leadership programmes in 26 South Auckland high schools benefiting approximately 4,950 students.

Youthline's youth workers also work alongside young people identified as "on the edge" providing face to face mentoring. Our youth workers mentor young people identified as needing one on one support to encourage and inspire them. Youth workers aim to understand the strengths and weaknesses of each young person, then identify goals and milestones and develop a plan for successful implementation and progression. By walking beside a young person struggling and providing positive role models, Youthline aims to make communities safer and reduce risk taking behaviour. The AACT enabled Youthline's South Auckland youth worker team to provide over 830 one on one mentoring sessions to over 367 struggling Manukau youth.

We know that when young people feel connected to their community and valued by others they gain confidence and self-esteem. This in turn provides them with the strength to make improved life decisions, to think about the long term and reduces the likelihood of depression and risk taking behaviour.

Youthline support and development services have a wide reaching effect, not only through the programmes and mentoring our youth workers deliver to young people, but also to the families and communities they are connected with.

**With AACT's continued support Youthline is able to be there for struggling youth and support those wanting to learn and develop to become positive members of the community now and into the future.**



## CHRISTIANS AGAINST POVERTY "YES, WE CAN HELP YOU!"

Thanks to the support of Auckland Airport Community Trust, Christians Against Poverty (CAP) has been able to, and will continue to be able to help people like Ngatoto and her family find their freedom from debt.

Ngatoto, a mother of three living in Manurewa, found herself ready to give up on life because she was so deeply in debt.

As a single parent, she had juggled her children and debt repayments for a number of years. Over time, the pile of bills mounted, and as they grew, Ngatoto began to isolate herself from friends and family.



*"I felt so helpless; I couldn't do anything. I didn't have family [to help] and I didn't know what I was doing with my money. I was just stuffed," she shares.*

**Ngatoto was ashamed and afraid:**

*"I was scared I was going to lose my children because I couldn't provide for them."*

She knew she needed help, and on one of her trips to Work & Income, Ngatoto saw a brochure advertising free debt help from Christians Against Poverty.

When she made that first call to the free helpline, she was nervous – but immediately began feeling relieved as she spoke to a caseworker who said, "Yes, we CAN help you!"

**And what does that help look like?** The CAP Head Office team booked Ngatoto an appointment with Ngaire, a local Debt Centre Manager from the Debt Centre at LIFE South Church.

After 2 home visits with Ngatoto, Ngaire sent all her bills and debts owed to the CAP Caseworker team. They got to work negotiating with creditors and getting interest charges stopped. Then, they built a budget for Ngatoto that prioritised food and housing – allowing her to repay her debts at a rate she could afford.

With CAP handling the creditors, and Ngatoto repaying her debt through her CAP account – life became a whole lot easier! She could afford food, she had energy for her kids, and she could start planning for her future. That meant she got her driver's licence and joined the New Zealand Police!

Ngatoto has now repaid the last of her debt and became one of 702 CAP clients who are completely debt-free! She has savings, and knows how to manage her spending, and most importantly: she feels like a great mum with a bright future ahead of her and her children.

## **e: STATEMENT OF ACCOUNTING POLICIES**

### **Basis of Preparation**

Auckland Airport Community Trust has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

### **Goods and Services Tax (GST)**

All amounts are recorded inclusive of GST.

### **Income Tax**

Auckland Airport Community Trust is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

### **Bank Accounts and Cash**

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

### **Trustee Funds**

Trustee funds comprise of accumulated surplus over the years, Endowment Fund Reserves and Hardship Grant Reserves. Endowment Funds Reserve are funds left to build up and be used for major community projects at some future date. Hardship Grants Reserves are funds set aside for future approved hardship grant distributions.

### **Revenue from donations, fundraising and other similar revenue**

Donations/grants with no "use or return" conditions are recognised as received. Donations/grants with use or return conditions are recognised as a liability and recorded as revenue when the conditions are satisfied.

### **Revenue from interest, dividends and other investment revenue**

Revenue from interest is recognised as earned during the period.

### **Costs related to providing goods or services**

Costs are recognised on an accrual basis as services are provided to the Trust.

### **Tier 2 PBE Accounting Standards Applied (if any)**

The Trust has not adopted any Tier 2 PBE Accounting Standards in the preparation of these accounts.

### **Changes in Accounting Policies**

The Trust transitioned on 1 April 2015 from preparation of general purpose financial information in accordance with New Zealand generally accepted accounting policies ("NZ GAAP") to the Performance Report of Tier 3 Not-For-Profit Public Benefit Entities. The transition had minimal impact on the accounting policies of the Trust.

# TRUSTEES



## NOEL ROBINSON J.P - CHAIR

Noel was appointed to the Trust in November 2013 as an Auckland Council appointee. He recently retired after a lengthy term as Manager of the Papatoetoe Citizens Advice Bureau after a corporate career in the pulp and paper industry and later as CEO of a national sports body. Noel is active in many community and sports organisations. He is also a company director and a very active Justice of the Peace.



## SIMON LAMBOURNE

Simon Lambourne was appointed to the Trust in September 2015. He is Auckland Airport's Public Affairs Manager and responsible for the company's strategic communications and relationships with central and local government, media and the community. Prior to joining Auckland Airport in May 2013, Simon was the New Zealand Automobile Association's Public Affairs Manager and Auckland Transport Spokesperson. He is a former advisor to the European Commission's diplomatic mission to Australia and New Zealand and started his career working in the New Zealand Parliament.



## TAFAFUNA'I TASI LAUESE

Tasi has been a member of the Auckland Airport Noise Community Consultative Group for eight years and was appointed to the Trust as their representative in 2014.
